Message from the Mayor and General Manager

Mayors Foreword 2017/18



It is my pleasure to present the Balranald Shire council 2017 Annual Report.

This year has been extremely busy with the continuation of the Performance Improvement Order (PIO). To meet some financial improvements Council introduced a Special rate Variation. Council will continue to meet its commitments and provide quality services to our community.

In February 2018 Council hosted the Annual Western Division Conference. This was an opportunity for Local Government,

Committees of Management, government agencies and industry to come together to build their understanding of issues that face the diverse Western Division of NSW and discuss the impacts of legislative changes and State and Federal strategies and plans.

Council has been successful in receiving 3 major grants for the 2017/18 year;

Stronger Country Communities Funds \$2.29M; -

- Market Streetscape Revitalisation Project;
- Greenham Park Multi-purpose Centre Renewal Project; and
- Janelle Masters Memorial Pool Revitalisation Project.

Fixing Country Truck Washes (NSW) \$360K:-

• Upgrading of existing wash facilities to cater for road trains and lighting for 24-hour access.

Regional Growth Fund (Federal) \$1.3M;-

Our Rivers Our Region Project, which is a combined objective with six other shires totalling \$13.8M. Our specific projects include;

• A staged riverside and parkland trail development at Balranald township along the Murrumbidgee River.





- An all-access, short course loop trail (including riverside furniture) incorporating a second swing bridge at/near Riverbend Park.
- A boat ramp near Euston on the low side of Lock /#15 on the Murray River within Euston Regional Park.

We currently have some major developments commencing around our Shire, including several solar farms, an accommodation village for solar farm workers and mineral sands mining.

We have completed a number of capital works projects to improve our assets, including investments in roads, kerb and guttering, and our water and sewer systems.

Finally I would like to say that despite the continual changes forced upon us, the Council, staff and community continue to work together to keep our Shire moving forward, to ensure that we can all share in a more resilient future.

I trust the 2017/18 Annual Report will provide you valuable information on the operations and management of your community.

General Managers Foreword 2017/18

Over the past twelve (12) months Council has seen significant change in how we operate. The past year has proven to be one of mixed news for Council and our Community; with the ongoing completion of the Performance Improvement Order and the implementation of the Special Rate Variation. These challenges have forced Council to review how it operates and to look at how we engage with the Community. As such, we have undertaken an organisational structure review and improved internal working practices to achieve efficiencies in service delivery.



Council's priority is to ensure that we have a sustainable structure to ensure the continuity of service delivery to rate payers. As a result, a sustainability and capability study has been undertaken and Council has modified its structure and operating methodology to ensure that we are positioned to maintain our current workforce and to generate opportunities for our local businesses and contractors. The Mayor, Councillors and I have recognised that the economic status of the Shire has been in decline for several years and as such, have taken a direct approach to support our current industries and to promote opportunities for growth.

With approximately two billion dollars (\$2B) of proposed and actual development planned to occur within the Shire over the next three (3) to five (5) years; Council faces a unique challenge of ensuring that our local policies and management practices are structured to generate the highest possibility of success for each of these projects. These projects include: two large scale Solar Farms, two Mineral Sands Mines and increases to the Tourism and Cultural Tourism Industries. As such, Council is currently reviewing the strategic planning schemes including our Community and Strategic Plan, the Operational Delivery Plan, the Asset Management Plan and the Local Environment Plan. The highest priority with any of the proposed developments is to ensure that they complement our lifestyle and that they provide opportunities for local employment. Discussions with each proponent have resulted in assurances being given that local suppliers and workers will be given priority over the outsourcing of services and supplies.





Overall the past twelve (12) months has been very positive and although we are currently going through some extremely trying times with the drought our future prosperity as a Shire is strong. I am encouraged by the proposed growth for our region and look forward to the opportunities that will be presented over the coming years.

The professionalism and dedication of Council staff is a genuine display of the pride that we take in being the key representatives of our community. The performance standards delivered by all work areas is of the highest standard and I am particularly proud of the fact that through prudent management, Council has maintained its reserve and managed to deliver the majority of our Capital Works Program.

On a final note, I would like to thank the Balranald Community and Staff for the combined efforts over the past twelve months. It is through the close working relationship that Council and the Community hold that we will continue to prosper.





District Overview

About our Community

Located 850 km south west of Sydney and 450 km north of Melbourne, Balranald Shire Council covers an area of 21,346 square kilometres. Major townships within the Shire are Balranald (population 1343*) and Euston (population 839*), located on the banks of the Murrumbidgee and Murray Rivers respectively. * Statistics from 2016 ABS

Balranald Shire has a population of 2,361. The name Balranald originates from Scotland and dates back to 1837. Balranald developed as a thriving inland port and was proclaimed a municipality in 1882, becoming the Shire of Balranald in 1956. Balranald Shire shares boundaries with Central Darling (north), Murray River Council (south), Hay (east) and Wentworth (west). The Murray River forms the southern boundary.

The Shire's economy has traditionally relied upon dry-land and irrigated agricultural production of grains, wool, sheep meat and beef (valued at more than \$80 million in 2006). However primary production is diversifying to encompass horticulture, viticulture, organic agriculture and the growing of fruit and nut trees. More recently mineral sands and solar farm development have joined the diversification of business in Balranald Shire council. Tourism is also recognised as an important economic driver.

Balranald Shire boasts a progressive, well serviced and vibrant community that is committed to continued regional growth and sustainability.

Council is a forward thinking organisation that has identified and pursued opportunities to foster strong economic growth through the development and implementation of the Balranald Shire Economic Development Strategy.

Balranald developed as a thriving inland port and was proclaimed a municipality in 1882, becoming the Shire of Balranald in 1956. Balranald Shire shares boundaries with Central Darling (north), Murray River Council (south), Hay (east) and Wentworth (west). The Murray River forms the southern boundary.

Balranald and Euston are both situated on the Sturt Highway, providing easy access to nearby centres such as Swan Hill and Mildura. Balranald has a sealed airstrip, an established hospital, dentist, two schools and an early learning centre. The town has well-maintained parks and gardens, good sporting facilities and is a busy retail and commercial centre. Euston is a vibrant community, which is in a growth area of the Shire. Expansion of viticulture has occurred predominately in this area. The township boasts one of the finest clubs in the region.





Recent significant developments include:

With the success of receiving three major grants Council has been able to enhance our Shire with the following projects;

- Market Street will see positive changes as part of a streetscape revitalisation project
- The centre for sport in Balranald, Greenham Park, will see a Multi-Purpose Centre renewal project and the
- Balranald Janelle Masters Memorial Pool will see a revitalisation project take place.

This will be achieved with funding received from the Stronger Country Communities grant totalling \$2.29M; - All three areas are used extensively by the community and these projects will enhance the look and functionality of these areas and facilities.

\$360K was received from Fixing Country Truck Washes (NSW) to assist with upgrading existing wash facilities and to provide lighting at the truck wash giving 24-hour access to cater for road trains in our community.

The Annual Western Division Conference was hosted by Council in February 2018. With attendees from Local Government, Committees of Management, government agencies and industry, the objective was to assist in building an understanding of issues that face the diverse Western Division of NSW and to discuss the impacts of legislative changes and State and Federal strategies and plans.

A \$1,001,025 grant was received as part of the Regional Growth Fund (Federal) which is a combined objective with six other shires totalling \$13.8M. Under the Our Rivers Our Region Project, we have the following specific projects scheduled to utilise these funds;

- The Balranald township along the Murrumbidgee River will see a staged riverside and parkland trail development
- The Riverbend Park will see an all-access, short course loop trail (including riverside furniture) incorporating a second swing bridge
- Euston will see a boat ramp established on the low side of Lock /#15 on the Murray River within the Euston Regional Park.





We currently have some major developments commencing around our Shire, including several solar farms, and an accommodation village for solar farm workers. Extensive mineral sand exploration continued within the Shire during 2017/18 with the potential extraction phase envisaged to create up to 200 jobs. This will provide diversification to the region and significant flow-on support industries.

Council has a strong partnership with the National Parks and Wildlife Service of NSW to develop and promote Yanga and Mungo National Parks as tourism destinations, to build upon the existing popularity of the area as a place to camp and fish.

The continued growth of the Euston horticultural industry and the expansion of the Euston Club continue to provide businesses opportunities.

With approximately two billion dollars (\$2B) of proposed and actual development planned to occur within the Shire over the next three (3) to five (5) years; Council faces a unique challenge of ensuring that our local policies and management practices are structured to generate the highest possibility of success for each of these projects. The highest priority with any of the proposed developments is to ensure that they complement our lifestyle and that they provide opportunities for local employment. Discussions with each proponent have resulted in assurances being given that local suppliers and workers will be given priority over the outsourcing of services and supplies.

About our Council

Your Rates at Work

Council assesses 1,646 properties. Our sources of funding are made up of rates, grants from Commonwealth and State Government, and fees and charges. Council collects rates to provide essential infrastructure and services to the community each year. Rates are determined in accordance with the *Local Government Act 1993* and are calculated from property valuations supplied by the NSW Valuer General. The rates levied are combined with the other sources of revenue, to provide the community with a range of services and facilities.

Special Rate Variation

During the 2017/18 financial year, Council resolved to make application to the Independent Pricing and Regulatory Tribunal (IPART) for a Special Rate Variation (SRV) of 10% per year for seven years.

The fundamental basis of the SRV was centred on the limited capacity and capability of Council to become financially sustainable under the current rating and income structure and was struggling with compliance and legislative obligations.

Following Council's Performance Improvement Order, it was necessary to assess the financial viability of the Balranald Shire Council. A Long Term Financial Plan was developed which clearly highlighted that the current operation was financially unsustainable particularly in effectively delivering current services and managing, maintaining and funding infrastructure assets at a sustainable level. Council's location and size significantly increases the cost of service delivery and coupled with a very low rate base to anchor the various services required in a modern Council, deemed the Council unsustainable in its current form.

Council developed and adopted a Community Engagement Plan for consultation on the proposed SRV and their implications. Council undertook community consultation and engagement in accordance with the plan. Following the end of the consultation period, a Community Engagement and report were prepared and considered by Council and the SRV application was made.

IPART approved the SRV applicable from 1 July 2018.

To assist ratepayers to understand how Council spends the revenue collected, all works and services provided by Council have been classified into 15 functions. These functions are then shown with a dollar rate per \$100 of revenue collected to provide a basis of understanding how Council spends funds.





For the 2017/18 financial year, Council's main expenditure commitment was in the area of road services (\$27.13 per \$100 collected) and capital infrastructure works program (\$15.61 per \$100 collected). The table below summaries the actual expenditure for the 2017/18 financial year for each \$100 of revenue collected by Council.

Integrated Planning and Reporting

Balranald Shire Community Strategic Plan 2027

Under the NSW Local Government Act 1993, Balranald Shire Council adopted the integrated planning and reporting framework. This framework incorporated the development of a Community Strategic Plan, Balranald 2027, and is the overarching document that will be supported and integrated into all of Council's other planning documentation.

In 2012 Council engaged with its community and developed the Community Strategic Plan – Balranald 2022 which established the community's vision and which guided the direction of the Council.

After the September 2016 elections, Council reviewed the Balranald Community Strategic Plan (CSP) and consulted with the community to test the validity and currency of the plan. Subsequently, Council developed the Balranald Community Strategic Plan 2027 which was adopted by Council at its meeting on 27th April 2017 and is current for a period of four years.

Other Council Plans relevant to the CSP are

- The Delivery Program
- The Resourcing Plan
- The Annual Operational and Capital Works Plan





Review and Strategic Directions

Balranald Shire 2027 is not a Council plan, but a long term plan for all stakeholders with an interest in the future of the Balranald Shire and its communities.

In compliance with the Integrated Planning and Reporting Framework, the Balranald Shire Council has developed;

- A Community Engagement Strategy based on social justice principles for engagement with the local community;
- A Resourcing Strategy for resources required to implement the strategies established by the community plan that the council is responsible for including a long term financial plan, a workforce management strategy and an asset management plan policy, strategy and plans;
- A Delivery Program detailing the principle activities to be undertaken by council to implement strategies established by the CSP within the resources available under the Resourcing Strategy over 4 years; and
- An Operational Plan detailing the activities to be engaged in by the council during the year as part of the delivery program covering that year including a statement of revenue policy and a detailed annual budget.

To comply with the reporting requirements of the legislation and the Planning and Reporting Guidelines for Local Government in NSW, Balranald Shire Council will establish the following reporting processes:

- An Annual Report outlining achievements against the Delivery Program and effectiveness of the principal activities undertaken in achieving the objectives in the CSP;
- Audited financial statements as part of the Annual Report;
- Progress Reports at least every 6 months in respect to the principal activities detailed in the Delivery Program; and
- Budget Review Statement, delivered not later than 2 months after each quarter (except the June quarter).

Balranald Shire 2027 is designed to have a 10 year life; however, it is not expected that the CSP will be set in stone for that period. Every four years the Balranald community will have the opportunity to revisit and modify Balranald Shire 2027 when a new Council is elected. Each review process will roll the plan forward by another four years, ensuring the Balranald community always has a 10 year plan.

Our library has 732 registered members and a total lending stock of 13,638 items. This consists of print book stock of 12,997 items, with 900 of these being large print books and audio books.

The library has full communications facilities with three public access computers with internet access and Wi-Fi. This year we also acquired talking books and additional shelving with funds donated from the State Library.

Children from the local childcare centre have visited the library to be entertained by a story time session.

The State Library sponsors a program that is available at our library called Borrowbox. This program provides access to ebooks.







Bidgee Haven Retirement Hostel

Compliance with the Carers Recognition Act (2010) (CR Act) s8(2)

Council owns a fully accredited 15 bed aged care facility, the Bidgee Haven Retirement Hostel. In accordance with Carers Recognition Act 2010 (CR Act), s 8(2) Council meets all its obligations under the Carers Recognition Act.

The Council owned Aged Care Facility had a significant financial turnaround during the 2017/18 financial year with a profit of \$132,000 compared to a \$588,000 loss in the previous year. This can be attributed to a change in management, a committed and dedicated Hostel Manager and her staff, and a changed set of processes.

The facility has been fully booked with Residents enjoying the homely environment, home style meals cooked for them and many activities. Special Events are celebrated involving Residents, their families, staff and other community members. Events celebrated this year included Christmas Day, an Australia Day celebration with a visit from the Australia Day Ambassador, Easter celebrations, Remembrance Day, Anzac Day, special authentic international dinners and many external excursions.

The Disability Inclusion Action Plan includes timelines to guide the completion of the actions. The process will be monitored and evaluated through the Integrated Planning and Reporting cycle.

Implementation of the Plan will be undertaken by the responsible Business Units. Each action will be monitored and reported against for the periods 1 July - 31 December and 1 January - 30 June of each year.

The Director of Corporate and Community Services will monitor the overall implementation of the Plan and the integration of its actions into Council's new Delivery Program and annual Operational Plan.

Positive feedback was provided on how businesses within the Shire sought to employ people with a disability.

Council advertised in local newspapers and also on local notice boards for interested community members to complete a questionnaire about how Council could make its Shire more inclusive for residents. Council staff also visited a number of people with disabilities to seek their feedback.

There was a series of questions in a survey asking the participants how the Balranald Shire can support and allow for people with a disability to fully participate in community life. Many of the questions asked were about council facilities and accessing them.

There were around 57 responses, men and women from the ages of 25 - 90 years, who completed the survey and gave their opinions on how the Balranald Shire Council can support both those with a disability and their carers'.

Key community responses highlighted the importance of being involved in the local community and having access to appropriate services and recreational and social opportunities.

The majority of challenges identified by participants related to mobility (in terms of navigating the built environment).

The answers in many of the surveys identified opportunities for Council to improve accessibility for those with a disability and included suggestions such as:

- Placement of braille signs on toilets could assist those with vision impairment;
- Installation of automatic doors on toilets and at key Council facilities could improve accessibility for those in electric wheelchairs;
- Improved layout of displays in Council's Visitor Information Centre to make it easier for those with a walker to get around;
- Lowering counter tops at Council facilities where the general public interact with staff; and
- Improving accessibility of and ease of use of footpaths and parks in the Shire for those with a mobility scooter or walking frame.

The participants of the survey also identified a need for more disabled parking spots around the town. This has been incorporated in the Street Beautification project that is scheduled for 2018-2020.

October saw the holding of two major tourism events in the Shire – Balranald 5 Rivers Outback



The weekend was complimented with the Red Bull Branched Out Competition where we saw the country's best tree climbers compete against each other in a timed race to the top of Balranald's iconic River Red Gums on the banks of Murrumbidgee River

Rounding out the weekend was a Cooking and Craft Show in Market Street and more live music at The Homebush Hotel.

Balranald Visitor Centre recorded a 19% increase in walk-in figures from 2016-2017 during over the weekend and The Interpretive Pavilion was up by 37% in comparison to the same time last year. Our free 24hr overnight RV Park located at the Discovery Centre donations were up by \$500 due to RV Travellers staying in Balranald to watch the Red Bull Event.

Enquiries about the events and attractions over the weekend increased by 252% compared to the same event in 2016-2017. For the first time, we also welcomed more Interstate visitors than Intrastate during October.







In November we welcomed the Return to Country and ancestral spirit of Mungo Man on his journey home to Mungo. A Smoking Ceremony in Balranald took place followed by a special event at the Balranald Discovery Centre to commemorate Mungo Man's journey home as well as honouring Mutthi Mutthi elder, the late Alice Kelly who lived in Balranald and was a custodian of Lake Mungo National Park and the Willandra Lakes region.

Her daughter, Mutthi Mutthi representative Patsy Wince (nee Kelly) who is a member of the Willandra Lakes Aboriginal Advisory Group committee and a member of the Repatriation Committee said *"It was of great significance that Mungo Man's last stop before going home to Mungo is in Balranald as he was discovered at Lake Mungo within the Balranald Shire, and Balranald was home to Mum".*



The return to Country and ancestral spirit of Mungo Man is about the sole of a culture, the harmony with nature and a burial site that is consecrated ground and a pertinent reminder that the spirituality and essence of a culture goes far beyond remains.



During December, Council encouraged and supported a Shop Local Christmas campaign with Balranald and Euston Christmas promotions. We took up advertising opportunities in print and on radio with shoppers having an opportunity to win prizes at participating outlets in the retail sectors.







At the Australia Day Ceremonies across the Shire, we acknowledged our residents within the Shire at gatherings in Balranald and Euston.

In Balranald, the warm weather didn't deter the crowds where The Honourable Sussan Ley MP attended the Balranald ceremony and led the affirmation pledge and spoke of her passion for rural Australia. Australia Day Ambassador Warren Kermond OAM captivated the audience with stories of his life and travels.

At the conclusion of the Balranald presentations Warren, along with Cr Purtill & Cr Jolliffe attended Bidgee Haven Hostel for a ceremony, including a recital of Dorothea Mackellar's' 'I Love a Sunburnt Country', which was followed by morning tea.

Don Cooke from Balranald received the award for **Sportsperson of the Year** for his achievements in the motorcycle field.



Responsible pet ownership and the requirements of the NSW Companion Animals Act 1988

In accordance with Clause 217(1)(f) companion animals play an important part in the lives of our residents and as such our animal management facility provides a valuable service to the community with housing and care of companion animals and feral animals.

Balranald Shire Council continues to encourage responsible pet ownership by actively encouraging people to de-sex their pet at time of registration.

Balranald Shire Council encourages adoption rather than euthanasia for unclaimed animals and works with rehoming groups where appropriate. This year we have successfully delivered 4 dogs to a rehoming group and 5 dogs were returned to their owners. I dog was surrendered.

Unfortunately complaints about nuisance and destructive behaviour of companion animals continue to require significant Council resources. The major areas of complaints are stray, barking and aggressive animals.

We actively work to return companion animals to their owners but this can sometimes be difficult with animals that do not have identification or where we may not have current contact details. Balranald Shire Council has a very active social media profile and we find this is a very effective medium to return these animals to their owners.

All pound data and dog attack incidents have been lodged with the Office of Local Government. Dog attack data is lodged in the NSW Companion Animals Register as incidents occur. This year there has been 1 dog attack reported.

Council does not currently have any of its reserves as leash free areas.

Fund money used for managing and controlling companion animals totalled \$4,657

All funds received from the Companion Animal Register is received into consolidated revenue and is used to fund companion animal management activities such as ranger patrols, impounding and rehoming.
