## FROM THE ADMINISTRATOR

### COMMUNITY CONFIDENCE & SATISFACTION SURVEY

In the last Newsletter I mentioned that the Community Satisfaction Survey had been completed to measure the current level of community confidence and satisfaction with Council. A random sample of residents was contacted by telephone by the survey firm and asked a series of questions. The residents who were contacted provided feedback on their satisfaction and confidence levels. A report on the survey outcomes was received from the researchers last week and is available on Council's website now. The survey outcomes will inform future Council initiatives and enable us to compare our performance with future survey outcomes to determine if it is improving.

### ADVISORY COMMITTEES FRAMEWORK REVIEW

The advisory committees framework is currently being reviewed to better align committees with our Community Strategic Plan. The COVID-19 Public Health Order which limits public gatherings has caused us to be creative in the way we have communicated with you about this recently. Because we couldn't gather in person, we used Facebook webcasts and Zoom instead and I was able to observe these workshops. A big "Thank You" to our facilitator, Rachel Williams and to those of you who participated in these, providing useful ideas and feedback. A draft advisory committee framework was subsequently adopted for public exhibition at the May Council meeting. It is available now on Council's website and will be finalized at the June Council meeting. Your final input would be appreciated during the exhibition period. Expressions of interest will then be sought from our residents to become Advisory Committee members.

### DRAFT BUDGET FY 2020 - 21

A draft of the 2020-21 Operational Plan and Revenue Policy including the Budget will be considered at a Council meeting to be held on 26 May before going on public exhibition for comment. The documents can be viewed on Council's website and your comments would be appreciated. A series of public workshops are scheduled to be held in the first week of June in which face to face forums will be held in Clare, Euston and Balranald townships. These are to engage on any budget matters you may wish to raise and I would appreciate maximum participation in this.

Due to current COVID-19 restrictions these forums will be limited to a maximum of ten participants per session, including staff. To manage this, we will be breaking the sessions up into the below schedule, and bookings will be required to participate.

### TOWARDS SOUND FINANCIAL MANAGEMENT

Last October, the New South Wales Office of Local Government drew Council's attention to its apparent failure to follow the principles of sound financial management identified in Section 8B of the *Local Government Act 1993*. By late January 2020, when Council found itself under administration, the situation had not been rectified. Ultimate responsibility for restoring sound financial management arrangements at Council lies with me as Administrator. A change in Council's approach to financial management is required and I want to keep the community progressively informed as steps are taken to achieve it.

Council is subject to the *Local Government Act, 1993* (the Act). Section 8B of the Act provides:

#### "8B Principles of sound financial management"

*The following principles of sound financial management apply to councils--*

- (a) *Council spending should be responsible and sustainable, aligning general revenue and expenses.*

- (b) Councils should invest in responsible and sustainable infrastructure for the benefit of the local community.
- (c) Councils should have effective financial and asset management, including sound policies and processes for the following--
  - (i) performance management and reporting,
  - (ii) asset maintenance and enhancement,
  - (iii) funding decisions,
  - (iv) risk management practices.
- (d) Councils should have regard to achieving intergenerational equity, including ensuring the following--
  - (i) policy decisions are made after considering their financial effects on future generations,
  - (ii) the current generation funds the cost of its services."

The specific areas of concern about Council's financial management mentioned by the Office of Local Government were:

1. Making changes to the 2019-20 business rate and sewer charges that ignored the substantial work undertaken in developing the 2019-20 revenue policy and proposed rating structure;
2. Apparently "inequitably" reducing the rates payable by the gypsum mine/s and increasing other business categories;
3. The need to actively renew expired leases/licences including those for the Football Club grounds and facilities;
4. The need to ensure that the Football Club is required to pay market rent as determined in the expired lease/licence in the interim, until a new arrangements have been finalised, and to ensure that the rent is paid accordingly, that this is transparent and delivers the best community value; and
5. The need to ensure that the charges identified in the lease to the gypsum mines/s and the relevant development approval are levied, including road restoration charges.

I should mention that in appropriate circumstances in determining rents, Council has a discretion to allow a rental rebate to a "charitable" or "non-profit" organisation. The amount of any rebate would normally reflect both the lessee's contribution to the community and its capacity to pay.

Regarding the sewerage charges, a resolution was adopted at the April Council meeting requiring a financial model of the draft non-residential sewerage charges comparing the current framework with an option to adhere to the two-part usage and access charge format referred to in the *Best-Practice Management Water Supply and Sewerage Guidelines* (and any other suitable option) to be provided when the Draft 2020-21 Revenue Policy is

presented to Council for consideration. At the May Council meeting, that model was considered with a view to determining an appropriate basis for making non-residential sewerage charges to be included in the Draft 2020-21 Revenue Policy that will be on exhibition for public comment from 26 May available on Council's website.

To remedy the Office of Local Government's concerns outlined above, at the May Council meeting, Council resolved:

"That in response to the matters raised in the Office of Local Government's letter to Council dated 24 October 2019:

1. Council will adhere to the principles of sound financial management laid down in Section 8B of the Local Government Act 1993 in all its affairs,
2. The Draft 2020-21 Operational Plan and 2020-21 Revenue Policy is to be prepared by the General Manager on the basis referred to in "1" above;
3. All expired leases/licences on Council property, including mines, and public recreation reserves where Council is the Trustee, be reviewed expeditiously to ensure they are actively renewed or replaced with each lessee to be required to pay market rent as determined in the expired lease(s) in the interim, until a new lease has been finalised;
4. All future leases/licences incorporate a fair market rent. In appropriate circumstances, the lease may also incorporate a rent rebate reflecting the level of community contribution performed by the lessee and its financial capacity;
5. Council ensure that the rent is paid in accordance with the terms of each lease, that this is transparent, and delivers the best community value;
6. The rents, Council charges, and any charges for other services provided for in each lease be actively levied and recovered;
7. The charges identified in the (Crown) lease to the gypsum mine/s and the development approval be levied and recovered, including relevant road restoration charges;
8. COVID-19 hardship arrangements be temporarily applied to recovering lease debts where individual circumstances warrant this;
9. Each lessee be notified of this decision and the process that Council will now follow to implement this decision pertaining to their lease; and
10. The Office of Local Government be notified of this decision."

### DOMESTIC FIREWOOD PERMITS – YANGA NATIONAL PARK

Permits are available from 1<sup>st</sup> May until 30<sup>th</sup> September 2020 for domestic firewood collection on Yanga National Park. The available firewood is from a single collection point and consists of redgum milled timber offcuts (sleeper backs).

Permits cost \$25/tonne or \$12.50/tonne for pensioner concession with a limit of 6 tonne per household per year.

Permits are only available to residents of Balranald and Murray Rivers Shires.

## NSW Government COVID-19 Response

### From Friday 15 May, the following activities will be allowed in NSW:

- Outdoor gatherings of up to **10 people**
- Cafes and restaurants can seat **10 patrons** at any one time
- Households can have up to **5 visitors** at any one time
- Weddings can have up to **10 guests**
- Indoor funerals can have **up to 20 mourners**, outdoor funerals **up to 30**
- Religious gatherings and places of worship can have up to **10 worshippers**
- Outdoor equipment can be used with caution
- Outdoor pools can open with restrictions
