SUCCESSFUL GRANT APPLICATIONS

Council has been successful in obtaining funding for two major projects from the Stronger Country Communities Fund (Round Three) grants program:

- Balranald Tennis Upgrade Project Stage 1 [\$287,504]
- Balranald Cultural & Creative Learning Centre (BCCLC) [\$284,378]

Balranald Tennis Upgrade Project - Stage 1 the first stage of the Tennis Club Upgrade Masterplan seeks to upgrade four out of the six lawn courts to synthetic turf hard courts.

Balranald Cultural & Creative Learning Centre (BCCLC) This project will involve construction of the building alongside Balranald Art Gallery. The building will include a creative space with two large floatina workbenches, furniture, cabinetry, sinks, and a smart provision for art storage ceiling-to-floor sliding panels/frames for mounted works. There will also be off-street parking and associated landscaping/drainage central to both the BCCLC and the main art gallery building.

ADVANCE NOTICE OF ROAD CLOSURE

The Marma-Box Creek Road between Bidura and lona corners will be closed to all traffic for two days in coming weeks while bitumen works are carried out. GENERAL MANAGER RECRUITMENT

One of the immediate tasks for twenty of the advisory committee registrants was to provide input into the process of selecting Council's new General Manager. The search has already commenced and I am confident the job will attract high quality candidates. The recruitment of a new General Manager is expected to take 2 to 3 months. The recruitment process follows the NSW Office of Local Government's Guidelines for the Appointment and Oversight of General Managers with Local Government NSW Management Solutions (LGMS) as facilitator. LGMS is a management consulting company that specialises in providing recruitment and human resource services to local government.

The General Manager is responsible for managing Council staff and will work closely with me to plan, deliver, and review a broad range of services to our Shire. The General Manager develops and implements strategies which will support the growth and development of the local government area and ensures that Council services are customer-centric. The role is responsible for the efficient management of Council's finances and for inspiring innovation and creativity within the organisation to address diverse and complex issues. The General Manager plays a major role in liaising with the community, government agencies to seek grant funding, and representing the organisation to stakeholders.

I believe that the current complexities facing the Shire require the experience and expertise of a senior local government manager who understands the legislative and statutory framework of local government, the issues and challenges facing rural councils in NSW, and who is willing to work collaboratively with me as the Administrator and Council's governing body, and with the community to deliver quality, affordable and efficient services to the community and to develop Council's long term strategic plans.

As an initial step towards this recruitment, twenty of the people who are now appointees to Council's advisory committees met recently with Mr Mark Anderson from Local Government Management Solutions to describe what they believe are the specific attributes required in the new General Manager to be successful for this community. This input was then incorporated into the position description and information pack. Two community members will join me on the selection panel, with ultimate statutory responsibility for appointing the General Manager resting on me. I anticipate that the immediate challenges facing the new General Manager with Council being under administration for the next four years will appeal to a strong community builder with the right set of talents and strengths to work with me on restoring community confidence and launching the Council back onto the right trajectory.

COUNCIL MEETING NEWS

The following matters were dealt with at the 15 September 2020 Ordinary Council Meeting:

- Council adopted the Local Strategic Planting Statement. This is a document that draws together and summarises planning priorities identified within state, regional, district and local strategic work.
- Council will initiate the process to amend the Balranald Local Environmental Plan 2010 so as to provide for the approval with conditions of caravan parks and manufactured homes estates on land less than one hectare in size. This would have the effect of giving Council the flexibility to consider on their merits proposals for multiple transportable dwellings on holdings. This should help with affordable houses for temporary and seasonal workers.
- Robinvale Waste was granted an extension of its management contract for the Euston Landfill for a period of 5 years. The decision will result in improved security and site management infrastructure.

PREPARING FOR THE WARMER WEATHER

As spring sets in we are experiencing some amazing weather but soon after the gorgeous spring comes the blistering summer. As much as we love the long days and warm nights it is important think ahead to ensure we all get through the summer safely! Hazard reduction please be sure to clean up your yard and gutters now to reduce potential burning material and snake hiding places!

Remember, fire permits are required for most types of fire during the Fire Danger Period and heavy penalties apply for breaches of the NSW Rural Fires Act. A permit sets out the rules around how a fire is lit and maintained, and lets firefighters know when you are conducting burning activities on your property. ARE YOU PREPARED FOR THE BUSH FIRE DANGER PERIOD?

Thursday the 1st of October 2020 will mark the official start of the statewide statutory Bush Fire Danger Period (BFDP) and the NSW Rural Fire Service (NSW RFS) is urging residents to prepare for the fire season now. The NSW RFS is encouraging property owners to protect their assets from bush fires by creating and maintaining fire breaks on their land. NSW RFS Superintendent Steve Walker said Asset Protection Zones (APZs) should be maintained all year round as they are a critical part of property preparation. "A properly constructed and maintained Asset Protection Zone can help slow or even stop a fire from reaching a home or other important assets, such as crops, sheds, homes and expensive equipment" "Livestock should also be part of a farmers' planning for Asset Protection Zones," Superintendent Walker said. "A stock rotation plan can help keep paddocks near buildings well-grazed and a clear area should be set aside as a refuge for livestock if a fire breaks out".

FRUIT FLY

Blossoms are on gorgeous display all over the shire, but as trees begin to bear fruit it is time to start thinking about how you will manage pests and harvest. Fruit fly infests summer ripening produce such as stone fruit and strawberries, tomatoes and capsicum. Now is the time to start thinking about implementing your control strategies to minimise the impact of this pest. Sanitation, such as picking up and destroying fallen fruit, is a very important part of any control strategy. This can work hand in hand with fly baiting and removal of any unwanted host plants.

WATER QUALITY

Blue green algae has begun blooming upstream. Council's water team are well prepared to respond to the situation and have already commenced the necessary additional water treatments to mitigate the affects of the algae. These additional treatments and increased testing will continue throughout the summer to ensure Council's drinking water supply remains safe for consumption.

As in previous years, the additional treatments can reduce most of the impact upon taste and odour from the algae, however it cannot be fully eliminated. While this reduced amenity is unfortunate the changes are cosmetic only. Our skilled water technicians are hard at work monitoring and managing our water supply to be safe and should any issues arise these will always be communicated to community without delay. Council thanks our water team for their dedication and commitment!

Council reminds residents that the Raw Water supply ("outside water") is an <u>untreated</u> supply. Algal blooms can cause waters to be unsafe for recreation. Algal alerts are issued by Regional Algal Coordinating Committees (RACCs) who are responsible for local management of algal blooms. Algal alerts are reported on the WaterNSW website https://www.waternsw.com.au/water-quality/algae or you may call the NSW algae hotline on 1800 999 457 for information.

INFRASTRUCTURE AND DEVELOPMENT HEADLINES

Marma Box Creek Road Reconstruction of Marma-Box Creek Road to extend the bitumen seal has commenced, with the expectation that about 10km of new seal will be constructed this year. Pictured above - Road being prepared for seal.

Main Road 296 - Kyalite - Moulamein Road From the Kyalite Caravan Park entrance to the Shire boundary section has received approval by Regional Road Repair ("REPAIR") programme for road widening. Works should be completed before Christmas.

Football/Netball Club Detailed design of new change rooms is in hand after final consultation with the Football Club. This project will be delivered through packages prioritising local trade contractors, under Council coordination.

Bidgee Haven Hostel Detailed design and contract documentation for the new high dependency wing is in hand. It is hoped that tenders for the works can be invited by the end of this month.

Euston Cemetery Installation of the new toilet is now complete, together with a new rabbit-proof perimeter fence. Tree planting and irrigation can now proceed when resources permit.

WHAT YOU NEED TO KNOW ABOUT TRANSPORTING HORSES IN NSW

A Transported Stock Statement (TSS) is a form which records the movement of a horse/s from one property to another. A TSS is a requirement of the Local Land Services Act 2013 and Local Land Services Regulation 2014 for the purposes of tracing horse movements for biosecurity purposes. A TSS is also useful in helping the NSW Police identify stock theft. A dedicated TSS for Horse Movement is now available online. This free PDF can be downloaded from the Local Land Services website and used repeatedly. It needs to be printed and completed with the details of the individual journey, including date and signature. This document has no serial number so CAN NOT be used for transporting any other type of livestock (eg. cattle, sheep, pigs or goats) as it does not meet National Livestock Identification System (NLIS) requirements. INTEREACH SERVICES IN BALRANALD

Intereach has recently opened an office in Balranald, located in the Bes Murray Community Centre at 95 Court Street, Balranald. The office will be open from Tuesday to Friday, 9am to 5pm. On hand will be an Intereach Community Linker which, as the name suggests, is the person who will 'link' local people to the supports and services they need. With a thorough understanding of communities in which we operate, Intereach is able to support linkages to services provided by a range of organisations. In Balranald this includes: Aged Care Services: Home Care Packages are available across the entire Intereach footprint. The Commonwealth Home Support Program helps senior Australians access entry -level support services to live independently and safely at home. Eligibility is based on your support needs and age, but could be appropriate if you are having trouble with everyday tasks and feel a little support could improve your health and wellbeing. Services which may be accessed through the program can include meals and other food services, personal care, domestic assistance, nursing, allied health and therapy services, specialised support and respite care. CHSP may also be able to help with domestic assistance including basic chores around the house, home maintenance or modifications, items to make you more mobile or assist in everyday living, community transport and homelessness support.

Reach Out And Relax (ROAR): supports young people aged 12 to 18 and their families who are showing early signs or are at risk of developing a mental health issue. The program works with children, young people and their families to improve their emotional health and wellbeing. Seek ROAR support if you are a young person finding things a bit tough, a parent worried about your child or teenager's mental wellbeing, or you need someone to talk to.

Family Services: Families are the fabric of our communities. Sometimes, however, keeping your family healthy, happy and well can feel like the hardest job in the world. In Balranald, Intereach can work with you as a parent or carer to build your skills, be strong and help take the stress out of caring for your children. Intereach can talk to you about why you are finding life tough to deal with, and this helps us understand the type of support that will suit you and your family, and what problems you want to tackle. We can provide information and referral to other services, counselling, court support and help with little things that can make a difference, like time management, budgeting, household management and personal development.

COVID-19 UPDATES

Applications open for a new grant to support small businesses in southern border communities

If you are a small business owner in Balranald LGA, you may be eligible to apply for the new Southern Border Small Business Support Grant.

The grant is designed to provide immediate, short-term assistance to help businesses adapt to impacts of the NSW/Victoria border closure.

How much can I apply for?

The grant amount is based on the business's decline in turnover.

- •\$5,000 (tier one): Small businesses (including non-employing businesses, such as sole traders) that have experienced a decline in turnover of at least 30 per cent
- •\$10,000 (tier two): Employing small businesses that have experienced a decline in turnover of at least 75 per cent.

What can I use the grant for?

The grant can be used to pay bills, to get financial and legal help, or to diversify business offerings to stay open in the new environment.

The funds can only be used for eligible expenses incurred after the NSW/Victoria border permit scheme was introduced on 8 July 2020, and for which no other government support is available. For example, the grant cannot be used to pay wages for staff eligible for JobKeeper.



COVID-19 & HAYFEVER



*Seasonal allergies do not usually cause shortness of breath or difficulty breathing, unless a person has a respiratory condition such as asthma that can be triggered by exposure to pollen.

What should you do if you suffer from seasonal allergies (hay fever)?

Since some of the symptoms of COVID-19 and seasonal alleraies are similar, it may be difficult to tell the difference between them. If you are unsure about what might be affecting you, please contact your GP. Most GPs are provide currently able to telehealth consultations for problems like these.

If you suffer from seasonal allergies, you should continue your current treatment regime to minimise your symptoms. You should also consider talking with your GP about having an effective treatment plan for your seasonal allergies and/or asthma before the hay fever season beains.

However, if you have any possible COVID-19 symptoms (even if you suspect it's just your first allergy attack of the season) you need to immediately get tested for COVID-19 to confirm your diagnosis. If you normally have seasonal allergies and you experience any new symptoms or a change in your symptoms, you should also get tested for COVID-19 straight away.

If your COVID-19 test result is negative, and you continue to have symptoms or recurrent talk with your GP about management plan during the COVID-19 pandemic.

Invitation to participate in a water quality survey and testing for the Balranald Shire Council Increasing Resilience to Climate Change (BSC IRCC) Project

Balranald Shire Council is committed to ensuring that all people in the Shire have access to adequate safe domestic water supplies. This commitment applies to pastoral properties and to those living in our towns who use tanks for drinking water.

Council is undertaking a survey of private water sources, water treatment and water use in order to:

- •better appreciate the dimensions of the water supply problems being confronted by residents in the Shire living on rural properties or using rainwater tanks
- •identify any possible health risks that may be present due to the quality of the water that people are using
- help to ensure that everyone can have adequate and safe domestic water supplies

For this survey, domestic water is:

Water used day to day by people for indoor and outdoor household and commercial purposes including drinking, preparing food, bathing, washing clothes and dishes, brushing teeth, watering gardens, swimming pools and children's play.

Securing adequate safe domestic water for the people of Balranald Shire goes beyond potable/drinking water supplies. It is more than water from your kitchen tap.

Domestic water encompasses all uses by which you and your family and friends or employees or visitors or guests (if you are operating a commercial activity), can come into physical contact with the water resources being used on your property. And, because of its poor quality, the water may or may not be a risk to the health of people who use it every day.

Council are inviting people on rural and remote properties in the Shire who are dependent on private sources of water for their household use to participate in this collaboration. Private sources include: surface water from farm dams or creeks or rivers; ground water from deep or shallow bores; and rainwater tanks that capture runoff from roofs. Separate tests will be undertaken for each source of supply being used.

People in Balranald and Euston who have rainwater tanks for domestic use (eg drinking, cooking, showers, bathing and children's play) are also invited to participate in the project.

We will forward further information on how you can participate in the water quality questionnaire survey and testing in the week commencing 5 October 2020.

We would like to have your completed questionnaire by 16 October 2020.

You will be able to respond either on-line via a survey monkey or return a hard copy of the questionnaire to the Project Team. Your contribution will help Council better understand the domestic water supply issues across the Shire and how we can work together to address them
