FROM THE ADMINISTRATOR (Cont.)

A review of environmental factors (REF) was required to satisfy statutory requirements to support Council's application for the relevant Crown licences and to ensure the project is undertaken in a sustainable manner. The REF examined all matters likely to affect the environment arising from the proposed activity. It established that it is not likely to significantly affect the environment or threatened species, ecological communities, or their habitats. An aboriginal cultural heritage due diligence assessment made recommendations in relation to training and heritage induction, mitigation measures for new access paths, and measures related to potential discovery of aboriginal objects or ancestral remains that will be followed by Council. The Balranald Local Aboriginal Land Council had advised that it was happy with the findings and conclusions of that assessment.

The REF concluded that the proposed works are justified and where additional permits are required, it identified processes that need to be followed to allow the works to proceed.

The project's benefits are:

- pedestrian access to the southern side of the Murrumbidgee River;
- formalising the current informal pedestrian track, reducing impacts on soils and the environment;
- · vehicle access management;
- improved recreational facilities;
- safer access to the area;
- improved cultural and environmental knowledge through signage; and
- improved Council current assets and new assets for community use.

The REF recommended that the proposal proceed, subject to implementation of a range of mitigation measures that it identified and compliance with all relevant statutory approvals, licences, permits and authorisations.

Council's community participation plan was used as a guide to the public exhibition process. Neighbours adjoining the area of the proposed works were notified of the proposal and it was advertised extensively in local media. Fifteen submissions were received during the exhibition period, including one petition. Although there was some local objection to the project in its proposed form, the majority of submissions received by Council favoured it.

Further aspects of the project including construction of a sound shell, weather shed, pavilion and timber wharf are envisaged at a later stage, subject to funding and these will trigger further community consultation.

ADVISORY COMMITTEES

Council's seven new Advisory Committees started to function throughout September and October. Their advice is starting to roll through to me now. I received the first of the Advisory Committee reports at the October Council meeting which included guidance on proposals to improve the Balranald riverfront, Discovery Centre, library and Bidgee Haven Hostel, plus insurance issues for sporting facilities, conversion of some tennis facilities to basketball, and development of a Youth Facebook page. Council has also asked the Executive of Chairs of these Advisory Committees to determine the Australia Day award recipients for the forthcoming 2021 Australia Day celebrations.

Reconstruction of Marma-Box Creek Road

Unsealed Road Maintenance Grading



Balranald landfill – out of hours facility for green waste

Council is aware that during the current growing season residents may find the opening hours of the Balranald landfill inconvenient for the disposal of green waste. A temporary skip has been placed outside the gates of the landfill for out of hours disposal. THIS IS FOR GREEN WASTE ONLY. This is a temporary measure that may be withdrawn if Council believes that it is being abused (such as normal household waste being left in the skip). A second locked skip has been provided for commercial users, who can apply for a key by contacting Council.

The BAM 2020 comes into force on 22 October 2020. The <u>Biodiversity Assessment Method 2020 – What's New fact sheet</u> outlines the key amendments made to BAM 2017.

Clause 6.31 of the Biodiversity Conservation Regulation 2017 provides transitional arrangements to minimise the impact that amendments to the BAM may have on proponents and landholders with a biodiversity assessment underway.

This includes assessments for development, activities, clearing, biodiversity certification and biodiversity stewardship agreements.

MEET CLAIRE

My name is Claire Butler and I am the Regional Recovery Officer for Far West NSW.

I live on a merino sheep station located between Balranald and Ivanhoe. I have worked in both local and state government community engagement roles, including five years on the State Council of the Isolated Children's Parents Association of NSW, advocating for access to education for rural and remote families, developing networks and pathways that help farming families and assisting in policy change at a NSW Government level.

Having run our own farming business, combined with working and volunteering off farm, I know the ebbs and the flows of farming and remote living.

We have experienced the hardships caused by drought as well as the intermittent good seasons that come with farming in a marginal rainfall area. We have also experienced the joys and the challenges of raising and educating children in an isolated area.

In my role as Regional Recovery Officer I will be travelling widely and often, meeting with individuals, businesses and local stakeholders and reporting back to the highest levels of Government on the grassroots issues that affect Far West NSW communities.

ABOUT THE AGENCY

The National Drought and North Queensland Flood Response and Recovery Agency works hand-in-hand with communities, all levels of government, charities and agricultural organisations to support farmers and other rural and regional Australians living through the immediate and longer-term effects of drought and flood.

Our aim is to ensure people and communities are given the support they need, and to do this we have established a national network of Regional Recovery Officers (RROs) to ensures farmers, regional businesses and communities are aware of what Australian Government assistance is available, how to access it, and to ensure it meets their individual needs.





Yanga Update - October 2020

After drying out last Summer Yanga Lake is filling again as result of extensive flooding of the Yanga Wetlands with allocated environmental water. This water has been making its way through key wetland sites since August and has triggered colonial waterbird breeding, topped up important native fish habitats and provided water for known Southern Bell Frog sites.

Yanga Lake is expected to continue to fill over the next few months and National Parks and Wildlife Service (NPWS) is working hard to reinstate the access to Regatta Beach using the existing road. This road has been closed for an extended period following the discovery of Aboriginal freshwater mussel shell middens on the road.



These middens were the subject of an archaeological excavation in May this year which found the sites to be very old! As well as shells the archaeologists also found charcoal fragments and heat retainers used in cooking, this coupled with the age of the middens make them quite important and a lengthy process continues to preserve the site.

NPWS has collaborated with the local Aboriginal community on the archaeological survey, research and protection works and will continue to work closely with all stakeholders to ensure the access to Regatta Beach occurs as soon as possible. At this stage it is not know how much water will flow into the lake or if it will reach safe boating levels, but we will be able to provide more information on the water and the access in the coming weeks.

CLIMATE CHANGE ADAPTIVE PRIVATE DOMESTIC WATER SUPPLIES ON **RURAL & REMOTE PROPERTIES**

Council is undertaking a survey of water adequacy and quality for our *Increasing Resilience to Climate Change (IRCC) Project.*, funded by the NSW Department of Local Government and assisted by NSW Department of Planning, Environment and Infrastructure. This is being done in order to:

- •help to ensure that everyone can have adequate and safe household water supplies
- •better appreciate the water supply problems being confronted by residents in the Shire living on rural properties or using rainwater tanks, and;
- •identify any possible health risks that may be present due to the quality of the water that is being used.

Council are inviting people on rural and remote properties in the Shire who are dependent on private sources of water for their household use to participate in this collaboration. Private sources include surface water from farm dams or creeks or rivers, ground water from deep or shallow bores, and rainwater tanks that capture runoff from roofs. People in Balranald and Euston who have rainwater tanks for household use (e.g. drinking, cooking, showers, bathing and children's play) are also invited to participate.
