## Community Advisory Committees - Your Voice to Council

### A Report from the Growing Business, Industry and Tourism Advisory Committee

The Growing Business, Industry and Tourism Advisory Committee, or GBITAC for short, has hit the ground running since forming in September last year. The committee has been consulted on a number of Council projects such as the plans for the Discovery precinct, the Riverside eco-trails project and funding distribution for infrastructure projects across the Shire including Balranald, Kyalite & Euston.

The GBITAC have already made a number of recommendations to Council which were adopted at the March ordinary Council meeting. The Administrator resolved to;

- Include the GBITAC as community representatives on future engagement with Water Infrastructure NSW on the Yanga Lake – Murrumbidgee Weir Proposal.

- Ensure that, at the next opportunity the **Discovery precinct** architect is visiting Balranald, the Director for Infrastructure & Development coordinates a walkover of the existing facilities at the precinct with the GBITAC and the architect.

- Refer the matter of the heavy traffic through Balranald township to consider safety and social impacts to Transport for NSW.

The GBITAC April meeting focused on developing an annual plan for the committee, scheduling guest speakers and visits to other towns to learn how to grow business, encourage industry & attract tourism to our Shire. The committee are also planning some familiarisation tours to local businesses and attractions with an open invitation to community to come along and discover what the region has to offer.

A major initiative the committee is working on with Council is aimed at collecting your development ideas for the region. "Project HQ" is a concept whereby an otherwise empty space temporarily becomes a hub for recording all those crazy ideas you have been discussing over a beer or cuppa, you know the one's, "What this town really needs is....". Community members can drop in to Council Office personally or there will be lots of other ways to contribute by emailing [council@balranald.nsw.gov.au](mailto:council@balranald.nsw.gov.au). These ideas are then threshed out in a public forum aimed at developing masterplans for all the Shire's towns and villages as well as contributing to a Community Strategic Plan.

Community Advisory Committees are your representative voice to Council. You can approach members to find out about Council projects, pass on a great idea or to raise a concern. Committee recommendations that are adopted through a Council meeting become resolutions of Council to be enacted by Council. Equally, the Council can consult the community through the Advisory Committees, asking for information, clarification or advice. It is all about moving away from an "us & them" mentality towards meaningful two-way communication where we are all 'community'. "Making decisions together" as per CES.

## INFRASTRUCTURE REPORT

### ROAD CONSTRUCTION AND MAINTENANCE

#### Regional Roads Construction

Earthworks are in hand for the widening and sealing of a 2km section of MR514 (Oxley Road) with pavement construction to follow and sealing in late May 2021. A contract has been awarded for the widening of **MR296 (Kyalite-Moulamein Road)** from the Kyalite Caravan Park to the Shire boundary..

#### Local Roads Construction

Formation and drainage work on the first stage of reconstruction and sealing of the **Weimby-Kyalite Road** has been completed and it is anticipated that a contract will be awarded for further works of this nature in late April. Preconstruction activity (survey and documentation) are in hand for drainage improvements and sealing of **Purton Lane** in Balranald.

Quotations have been invited for the replacement and duplication of a number of narrow grids on the Mildura-Ivanhoe Road and the **Oxley-Clare Road**.

The bitumen reseal programme for the current year will occur in late May, comprising recently constructed sections of **Ivanhoe Road and Oxley Road** together with a section of Mayall Street, Balranald.

Work will commence shortly on traffic calming of **Bertram and Taylor Roads**, Euston including some related improvements to these roads and their intersections with Morris Road. Community consultation on this project closed on 14 April 2021 with a number of submissions in support and none opposed.

### CIVIC ENHANCEMENT PROJECTS

Work is substantially complete on construction of the **Riverfront Precinct ecotrail walkway**, with an additional 1.9km loop being planned. Path construction on the town side between River Street and the Caravan Park is currently in hand. Following the decision to defer the proposed second footbridge, Council is exploring modifications to the existing **swing bridge** for disability access and emergency egress. Additional proposed elements on the town side of the river include a barbeque pavilion, riverside furniture, exercise stations, removal of some "snags" and improved traffic management in addition to elements such as toilets that were previously planned.

#### TOWN MAINTENANCE WORKS

The Operations team continue to carry out routine town maintenance tasks at Balranald and Euston and specific works as required from time to time. Town maintenance resources in Euston are now at full strength once more. Proposals will be invited shortly to prepare a masterplan for public spaces in Euston, including the town approaches.



## **BUILDINGS AND FACILITIES**

Tenders have been invited closing 4<sup>th</sup> May for new **football change rooms** at Greenham Park. These are designed to cater for the future introduction of women's football as well as facilities for mixed-gender umpires in response to changing trends in the sport.

Work is complete on the upgrading of electrical services to **Greenham Park Hall** to improve utilisation of the Hall and its surrounding open areas. It is also planned to purchase new furniture and construct a secure storage facility for Greenham Park Hall. Construction of a new disabled toilet is under way, with completion expected by the end of April. Tenders closing on 5<sup>th</sup> May have been invited for the upgrading of the **tennis courts** to sand-filled artificial turf.

Council is currently in negotiations with a preferred contractor for the proposed high dependency extensions to the **Bidgee Haven Hostel**. However the award of a construction contract will be deferred until the outcome is known of Council's application for additional funding for this project.

A request for proposals (RFP) has been issued to 5 architectural firms to finalise the design and documentation of the **Visitor Centre/Discovery Centre** project, following which (after review of the design and cost estimates) tenders will be invited for construction.

Quotations will be invited shortly for heating improvements at **Theatre Royal**.

A modular toilet has been ordered for **Balranald Cemetery**. The preferred location is being checked by ground penetrating radar to ensure that no unmarked graves will be disturbed.

A "walkover" to the Robinvale Weir by the Euston Progressive Advisory Committee on 25<sup>th</sup> March 2021 identified preferred enhancement works (signage, seating etc.) for **Euston Riverfront Reserve and Walking Trail**. Consideration is also being given to enhancement works for the **Euston-Robinvale walkway**.

Tenders have been invited for the design and construction of the **Balranald Creative Learning Centre**, closing on 5<sup>th</sup> May 2021.

The **Kyalite Progress Association** met on 8<sup>th</sup> April and identified the construction of steps linking Anzac Park to the **Kyalite Riverfront Reserve** as a preferred priority to be funded under the Local Roads and Community Infrastructure Programme.

## Increasing Resilience to Climate Change (IRCC) Project *BSC IRCC Information Sheet 05*

### The 'Bigger Picture'—adapting to *changing climatic conditions in your region!*

The 2017 NSW Office of Environment and Heritage report *Western Enabling Regional Adaptation – Far West region* provides a **snapshot of climate vulnerability in the Far West region**. Balranald Shire is part of this region.

The report states that heatwaves are projected to occur more often, be more intense and last longer and across most of NSW there will be more days over 40°C. Also, droughts, evaporation and fire weather will increase. And people will be more vulnerable to health risks from poor quality water.

NSW councils are key players in adaptation to climate change. They have responsibility for a broad range of functions that are likely to be affected, such as public infrastructure, local emergency responses, building regulation and planning, public health and environmental management.

With each local government area having a unique set of geographical, environmental, economic and social circumstances, the effects and risks of climate change will differ. Early planning and preparation can minimise long-term economic, social and environmental costs to communities.

For this reason, the NSW Government has provided the following information for councils to help residents understand, prepare for and minimise the impacts of future extreme events and hazards caused by climate change.

The No Interest Loan Scheme (NILS) is still available throughout Intereach's NSW service area, despite the challenges of the Coronavirus pandemic. Applications can now be completed over the phone or via video conference.



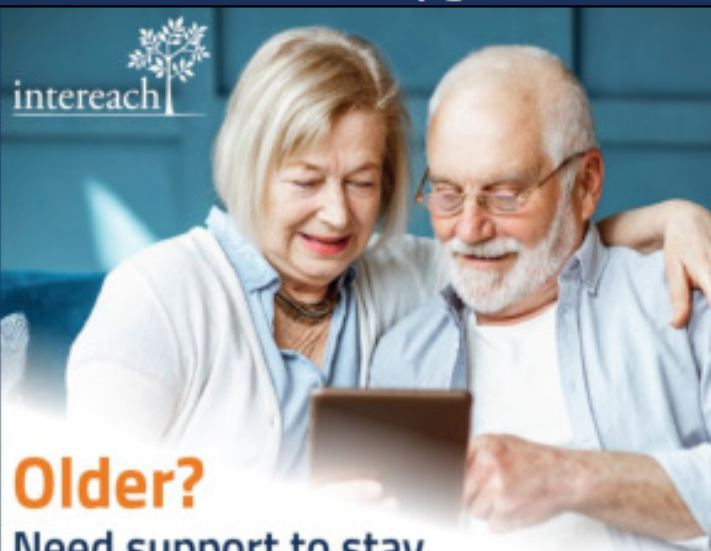
Eligible applicants can use NILS to purchase equipment such as laptops or printers, to enable work or study to continue from home.

Loans are available for essential goods and services, up to \$1,500. Repayments are set at an affordable amount over 12 to 18 months.

To be eligible for NILS you must have a healthcare or pension card, earn under \$45,000, have lived in your current residence for three months, and have a willingness and capacity to repay the loan.

### Yanga National Park Update

April 2021

Yanga Homestead has had a green transformation thanks to Advance Turf in Swan Hill and a herculean effort from the Balranald Football Club. On a sunny Saturday (10<sup>th</sup> April), the Yanga Homestead gardens received 2800m<sup>2</sup> of instant lawn totally transforming the space, that's three semi-trailer loads! Those familiar with the Homestead will know the flat area where the open-air movies were held in 2013. This entire space as well as the orchard is now all lawn making it the perfect venue for weddings and events.

The project was funded under a NSW Government stimulus package aimed at enhancing domestic tourism destinations.

Yanga National Park Ranger, Simone Carmichael, is thrilled with the lawns saying;

"The area is back to what it was like in the 80s with the whole bottom tier green lawn. This funding is all about supporting local businesses and to see the Balranald Footy Club get something out of it was an added bonus".

The footy club supplied 27 people on the day meaning the whole area was turfed in around 3 hours! It is hoped the Yanga Homestead will attract more visitors to the area with the gardens looking better than they ever have thanks to the new lawn and efforts of parks staff and a part-time gardener in the garden beds.

Weddings and other community events are welcome at the Yanga Homestead with a local wedding held only a week after the turf was laid.

To add to attractions at Yanga, the long-awaited reopening of the day-use area on Yanga Lake is imminent with contractors now engaged to upgrade the access road which has been closed since 2019. Regatta Beach is a popular recreation area on Yanga Lake, the discovery of 2,500-year-old Aboriginal Middens of Freshwater Mussel Shell led to an exhaustive investigation culminating in a special permit to cover the road so it can continue to be used. These road works should be complete by the end of June, hopefully the lake will refill allowing the public to once again enjoy this iconic waterbody.

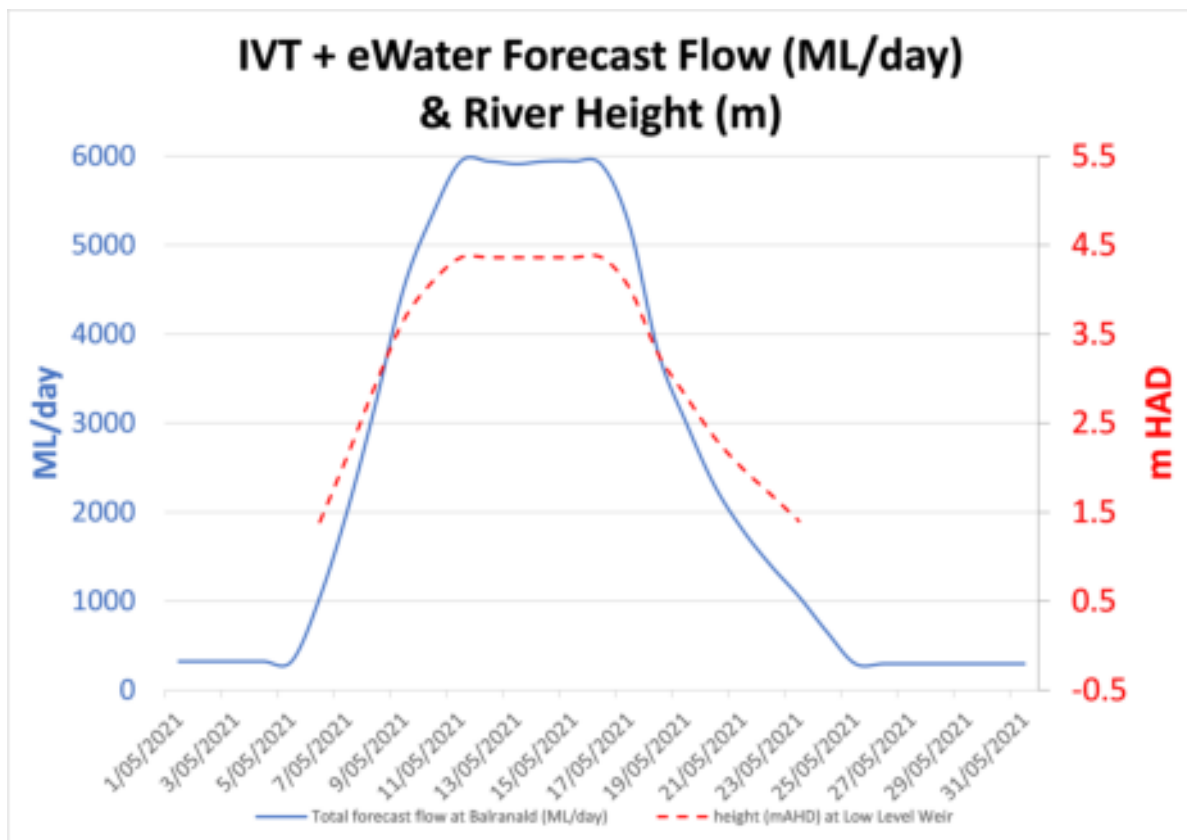




The Murrumbidgee Environmental Water Manager has ordered 35GL of eWater to coincide with an order of 30GL of Inter-Valley Trading water to maximise the their fish connection program. What this essentially means is the Murrumbidgee will reach a maximum forecast flow of just under 6000 ML/day for approximately 8 days from the 10-17<sup>th</sup> May (see graph). During this doubled-up water pulse, the river level will peak at ~4.3m at the Balranald low-level weir. Our River hasn't seen that sort of flow since mid-2017!

The pulse is also expected to deliver a minor top-up for Lake Yanga.

So dust your fishing gear off and get amongst it, because the fish will be running! And, of course – if you're boating – please take extra care on the river during this time as the flows are expected to be challenging.

# Fire preparedness and prevention expenses for primary producers

## For primary producers

This fact sheet explains your entitlement to claim tax deductions for costs you incur on fire emergency preparedness and prevention assets and activities on your primary production land.

It only applies if you are carrying on a primary production business on land in Australia. If you're not carrying on a primary production business (for example if you're a hobby farmer), you generally cannot claim the expenses described in this fact sheet.

## Capital costs and revenue costs

Special deductions are available for 'capital costs' – these are costs that provide a lasting benefit (such as the cost of business assets) and are otherwise not usually deductible.

Normal business operating expenses (such as the cost of maintaining firebreaks) are known as 'revenue costs' – these are deductible anyway under the normal deduction provisions.

You cannot claim a deduction for fire preparedness and prevention expenses that are private in nature (for example, expenses related to protecting your private residence).

## Water facilities

You can claim an immediate deduction for the cost of all water facilities you use in your primary production business, including for the purposes of fire emergency preparedness and prevention.

A water facility is:

- plant or a structural improvement that is mainly for the purpose of conserving or conveying water (for example, dams, tanks, bores or sprinkler systems)

- a structural improvement that is reasonably incidental to conserving or conveying water
- alterations, extensions or capital repairs to the above.

## What you can claim

You can claim a deduction for the cost of:

- quick-fill pumps
- high-rise drive-under water tanks
- lightweight water tanks for utility vehicles
- fire protection sprinkler systems in sheds
- fire dams.

## What you cannot claim

You cannot claim for the purchase or installation costs of a swimming pool, even if the pool is occasionally used to draw water for fire-fighting purposes.

However, if the pool is equipped with an extra pump to be used solely for fire-fighting purposes, you can claim the cost of the extra pump.

## Other capital expenses

### What you can claim

You can claim a decline in value (depreciation) deduction for the cost of the following assets based on their effective life:

- fire extinguishers
- fire shields made of non-combustible materials to protect water tanks and electrics on sheds
- wind breaks of permanent materials such as rocks and iron (where they have a limited effective life and can reasonably be expected to decline in value).
