## **CREATIVE LEARNING CENTRE**

Almost a year ago to the day, Council was notified by the NSW Stronger Country Community Fund Grants Office that the Balranald Community Creative Learning Centre (BCCLC) Project would be awarded funding.

Council has Recently concluded its request for tenders on the construction of the BCCLC (aka the Centre) and are in the process of finalising Construction contract with local Builder Peter Murphy Building . The Centre represents a very important, long-awaited goal for the Balranald Art Gallery Committee that will provide overdue storage space for valuable art works and also a highly-functioning creative learning space for the many creative classes conducted year round.

The Centre concept has been developed by Council in close consultation with the Art Gallery Committee. The exterior finishes of the Centre will be very similar to the main Gallery Building creating a seamless look from the front verge. A formalised off-street car parking area immediately in front of the BCCLC, adjacent to the Gallery building, will also be constructed.

Preliminary site investigations and detailed design work will be commencing as early as next week with site preparation and construction set to commence in early July.



# **OPERATIONAL PLAN & BUDGET**


At an extraordinary meeting on 27th May, Council adopted the Draft Operational Plan, Draft Budget and Draft Revenue Policy.

# Community Advisory Committees - Your Voice to Council A Report from the Balranald Beautification Committee

The Balranald Shire Council Beautification Advisory Committee - Balranald, was reformed on Wednesday 7th October 2020, with Toni Tyrer, Penny Jolliffe, Lynne Carter, Gaye Renfrey, Lea Lawrie and Karen Norfolk making up the Committee. Since then, Sue Morton and Val Bradbury has joined the Committee.

The Committee has successfully worked with the Balranald Shire Council on getting a Toilet at the Balranald Cemetery, which will be built later this year/early next year.

Recently the Committee made a Recommendation to the Council to move the Table and Seats from the Corner of Mayall and Market Streets (near the IGA Car Park) and move it to the lawn area at the Senior Citizens Centre. Happy to report that this has happened just recently.

The Committee's next project is to fill in the gaps of the Rose Gardens along Market Street, as many have died over the years. Also we are hoping to plant more plants where the River Stone Beds are along Market Street, bringing more greenery to the Main Street.

The Committee is currently looking into where trees are needed to be planted around Balranald.

The New Beautification Committee would like to say thanks to the outgoing Committee for all their hard work for Beautifying Balranald over their time on the Beautification Committee.

### FOOTPATH AND WALKING TRAIL WORKS

New footpath and Walking Trail sections have been or are currently underway in Balranald and Euston under the Commonwealth Government Local Roads and Community Infrastructure Funding Program (Round 1) to improve pedestrian accessibility and the amenity of both towns.

### **Balranald Township**

In Balranald, one footpath section on River Street (north of Market St), in front of Telstra tower has now been completed, to provide better accessibility to Market Street for pedestrians from the north-eastern section of town.

Another section on River Street (south of Market St) is currently under construction. This section will connect Market St to the newly constructed River Eco-trail that commences on Court St. This section of footpath will provide better access for residents, children with prams and tourists toward the riverfront and is the final piece of footpath of the Military Commemorative Trail showcasing the trails information boards.

Some changes are being made at the Court St end of River St to provide better access across to the start of the Ecotrail, with the inclusion of pedestrian ramps on Court Street, and there will be a slight realignment in the location of the starting point of the EcoTrail.

The Murrumbidgee Bridge approach is now finished with concreted footpath, providing access to the eco-trail on the southern side of the river, and two of our signature stainless steel jumping frogs were placed in the new footpath marking this signature trail.

### **Euston Township**

In Euston, a footpath section on Selwyn Street (south of Cary Street) has been completed, providing better access for local residents and school students.


Works are currently underway to replace the paved footpath on Murray Terrace with a pebblecrete footpath, to reduce the risks to pedestrians and improve the aesthetics and amenity along this terrace.

### **INFRASTRUCTURE REPORT**

### ROAD CONSTRUCTION AND MAINTENANCE

### **Regional Roads Construction**

Pavement construction of a section of MR514 (Oxley Road) has been completed.

Widening of MR 296 - Kyalite-Moulamein Road from Kyalite Caravan Park to Shire boundary contract has been awarded and contractors now mobilising next week.

### **Local roads Construction**

Works have been completed on the reconstruction of Marma-Box Creek Road bitumen sealing has been completed.

Formation works are in hand for the reconstruction and sealing of the Weimby-Kyalite Road to Windomal. Pavement works on an initial 2km stage will be completed next week.

Construction of drainage improvements and sealing of Purton Lane in Balranald are complete. Improvements to the Hatfield-The Vale Road at Binda will commence within the next couple of weeks.

### Unsealed road maintenance

Limited maintenance grading work is being undertaken to deal with safety issues as they arise.

A contractor has been appointed to carry out pre-seal preparation of the approaches to 12 grids on Marma Box Creek Road and D Block Road. Quotes for the replacement and duplication of a number of narrow grids on the Mildura-Ivanhoe Road and the Oxley-Clare Road have been awarded with works commencing 1st week June.

### Sealed road maintenance

The bitumen reseal programme for the current year commenced 24th May and will be complete next week.

Preliminary work is in hand for the installation of traffic calming of Bertram and Taylor Roads, Euston. Works are expected to commence early June.

Quotes have been submitted for safety improvements (line marking and reflective pavement markers) to the 100km of MR67 from Hatfield to the Shire boundary, as a requirement for the road to be used for haulage of mineral sands concentrate from the Atlas-Campaspe mine to the proposed railhead at Ivanhoe. Installation of additional signs and guideposts will be carried out by Council staff. Works will be completed by the end of June.

### WATER, SEWERAGE AND DRAINAGE

### **Balranald Sewerage Program**

A contract has been awarded for a switchboard upgrade for Pump Station No 2.

### INFRASTRUCTURE REPORT CONT'D

### **Balranald Water Network**

A contract has been awarded for a switchboard upgrade for the main raw water intake. A replacement pump for the intake has been purchased, awaiting contractor availability for installation. A contract has been awarded for the next round of AC mains replacement.

Quotations have been received for inspection and minor remedial works to the filtered water reservoir. This work will take place in September-October.

Quotations have been received for the inspection and desludging of the raw water reservoir, which is budgeted to be carried out next financial year.

### **Euston Sewerage Program**

Quotations are being sought for upgrading the main inlet structure and pump replacement.

### **Euston Water Network**

A contract has been awarded for the next round of AC mains replacement, with the contractor expected to mobilise within the next 2 weeks.

### **Kyalite Water Supply**

Council is progressing investigations and discussions with the local community regarding consolidation and potential taking of over the supply of raw water to the village. Following this assessment, consideration will be given to potential future supply of potable water.

### CIVIC ENHANCEMENT PROJECTS

### **Buildings and Facilities**

### **Balranald Cemetery**

A modular toilet will be installed at a location depending on unmarked graves.

### **Greenham Park**

All tenders received were rejected and negotiations with the preferred tenders will commence shortly. The works for the construction of new change rooms for the football club, designed to cater for the future introduction of women's football as well as facilities for mixed-gender umpires in response to changing trends in the sport will commence late September.

Purchase of new furniture for Greenham Park Hall and construction of a secure storage facility has commenced and a new disabled toilet has been installed.

Equipment Solutions Plus have been awarded the works to upgrade the tennis courts to sandfilled artificial turf, these works will commence in the near future.

### **Theatre Royal**

Installation of heating in the Theatre has commenced while the Theatre is currently out of action, it will be worth it to have heating as well as cooling.



### DOMESTIC FIREWOOD PERMITS - YANGA NATIONAL PARK

Permits are available now until 30th September 2021 for domestic firewood collection on Yanga National Park. The available firewood is from a single collection point and consists of redgum milled timber offcuts (sleeper backs).

Permits cost \$25/tonne or \$12.50/tonne for pensioner concession with a limit of 6 tonne per household per year.

Permits are only available to residents of Balranald and Murray Rivers Shires.

# COVID-19 AND WORKING FROM HOME – WHAT YOU NEED TO KNOW FOR TAX TIME

Whether it's a computer or generally entitled to claim these expenses either as part of a temporary short cut rate or separately, so make sure you take a look at the <u>guidance provided by the ATO</u> and of course speak to your tax advisorregistered tax agent if you have one

June 2021 – or the end of this financial year. Using this method, you can claim a deduction of The ATO extended the shortcut method for claiming work from home deductions until 30 80 cents for each hour you work from home as long as you are:

- Working from home to fulfil your employment duties or running your business and not just carrying out minimal tasks such as occasionally checking emails ortaking calls; and
- Incurring additional deductible running expenses as a result of working from home

The shortcut method is an all-inclusive rate and covers all deductible running expenses. If you do use the shortcut method, you need to keep a detailedrecordof the hours you worked at home using timesheets or diary notes as opposed to other methods where you must itemise and have receipts for each deduction you claim and apportion the claim forwork and private use. Also, if you usuallywork from home one day a week and due to an emergency situation such as COVID-19, bushfire or drought, you're required to work from home for an extended period, you will need to keep records for the actual hours you've worked from home due to the emergency situation as well as your usual working from home arrangements
